#### 1. Introduction of attendees and guests

Junichi welcomed our guests. The attendees introduced themselves.

#### 2. Approval of agenda

The agenda was approved.

#### 3. Approval of minutes of the previous meeting in Singapore

The minutes were approved.

#### 4. Presentation by Mr. Stephen C. Goss, the Chief Actuary of the US Social Security Administration (Ms. Alice Wade, Mr. Eli Donkar and Ms. Karen Glenn of the SSA will also participate)

Steven Goss kept a good presentation on Social Security Financial Status: Benefit Options (<u>link</u>). After the presentation we had an interesting discussion on the topic. Junichi thanked Steven, Alice, Karen and Eli for the brilliant presentation.

## 5. Report of the ICA 2014 with special reference to social security (Bob Conger)

Bob told us about the huge effort the 5 societies here in America have done to organize the Congress. There will be 107 different countries represented. Topics related to Social Security and Pension Benefits will be in the first half of the week. The Monday plenary speaker Professor S. Jay Olshansky will speak about changes in longevity in his presentation The Longevity Dividend: Altering the Future Course of Health and Longevity?

12 sessions on social security will be addressed:

- Determining Basic Retirement Needs
- Educational Topics for Social Security Actuaries
- Financing of Pensions and Social Security: Sustainability
- How to Achieve Retirement Income Adequacy
- Impact of Shifting Demographics
- Mathematical Modeling for Pension Actuaries
- Pension Regulation Updates from around the World
- Projecting Mortality and Life Expectancy
- Retirement Risk in the Drawdown Phase
- Social Security National Updates
- Target Benefit Pension Plans

# 8. Presentation by Ms. Carmen Pages and Mr. Mariano Bosch of the Inter-American Development Bank

Carmen introduced herself. She kept an interesting presentation on Better Pensions Better Jobs - Towards Universal Coverage in Latin America and The Caribbean (link). The presentation was based on a book written by her, Mariano Bosch and Ángel Melguizo. This book offers an analysis of pension systems from the perspective of the functioning of the region's labor market.

Ken as chairperson of the Supranational Relations Committee thanked Carmen for the good presentation and especially of how she succeeded in pointing out the universality of the model.

Carmen told us that the book has not yet been translated in English but in a couple of weeks it will. She promised she will send a pdf version of the book to all the committee members. She told that comments are welcome. We had an interesting discussion on the topic.

## 9. Report on the MoU with the ILO (Ken)

The MoU has been redrafting since the last meeting. Comments rose from the SSC were considered and now the MoU is shorter and it includes an annual work plan. There are not significant changes in the contents of the document (link). The document will be signed maybe in London or in Geneve.

## 10. Report on the ISSA activities (Jean-Claude)

We got a 6 months report from ISSA. Jean-Claude is the chair of the Steering Committee of ISSA. The World Social Security Forum has been successfully held in Doha, Qatar, 10-15 November 2013. The tasks for the triennium 2014-2016 are on line with the presentation given by Carmen Pages. One of the tasks is to develop ISSA actuarial guidelines. The 18th ISSA International Conference of Social Security Actuaries and Statisticians will be held from 16 to 18 September 2015 in Budapest, Hungary.

## 11. Discussion on Geneva Discussion Forum 2014 (Ken)

The 5<sup>th</sup> Geneva Discussion Forum will be held in Geneve on Tuesday September 30th. The agenda for this meeting is starting to be drafted; all suggests are welcome. The minutes of the last year forum can be found on the IAA website (link).

#### 12. Discussion on the establishment of the liaison TF with the Social Security Subcommittee of the European Association of Actuaries (Groupe Consultatif)

Therry, Giovanna and Severin are in the Social Security Subcommittee of the European Association of Actuaries. We decided there is no need to have a separate liason TF, they can report to the committee the progresses of the subcommittee.

## 13. Report on the OECD/IOPS Global Forum in Seoul, Korea (Junichi)

Juichi gave a brief summary on the global forum. A more detailed report can be found in the document (<u>link</u>).

#### 14. Any development on the Committee paper Stochastic Projections of the Financial Experience of Social Security Programs: Issues, Limitations and Alternatives (Warren)

Warren gave a brief update on the document.

#### 15. Report on the discussion of data issues (Martin Lunnon)
